

# 2023年施政報告(節錄)

## 1. 土地房屋

- 正規劃和進行十個公營房屋重建計劃,預計重建後可提供約32800個住宅單位
- 房委會繼續應用創新建築科技‧測試及改善「組裝合成」建築法的技術‧提升建屋質量 及加快建造流程
- 成立「解決劏房問題」工作組、設定最低標準、例如樓宇安全、消防及衛生要求、居住 面積等
- 額外印花稅的適用年期由三年縮短至兩年
- 買家印花稅和新住宅印花稅的稅率減至7.5%。

## 2. 有利育兒環境

- 即日起向每名在港出生的港人新生嬰兒派兩萬元現金,為期3年
- 2024-25 課稅年度起,父母的居所相關免稅額提高 2 萬元
- 預留 10%居屋及綠置居單位,讓新生嬰兒家庭優先揀樓
- 新生嬰兒家庭輪候公屋可縮減一年輪候時間,明年4月生效
- 2024-25 課稅年度起,政府在薪俸稅和個人入息課稅下,設立每年最多 10 萬元輔助生育服務稅項扣除
- 明年4月起,增加「在職家庭津貼計劃」下的住戶及兒童津貼金額15%
- 明年起於三年內·分階段增設十所資助獨立幼兒中心·提供額外近 900 個日間幼兒照顧服務名額
- 明年4月起,「幼兒中心家長津貼」由每月最多600元提高至1,000元

## 3. 安老服務

- 明年第二季起·把「長者院舍照顧服務券計劃」服務券適用範圍由現時參與計劃的護理 安老宿位·擴展至護養院宿位·並增加 1,000 張服務券·讓更多合資格長者不用輪候即 可選擇入住參與計劃的院舍
- 2024-25 年度,向「樂齡及康復創科應用基金」額外注資 10 億元
- 2024-25 年度,向「長者學苑發展基金」額外注資 8,000 萬元



## **Notice for Tenant**

Renewal Information

The staff of URA will contact the tenant after the owner accepts the offer from the URA. The URA will identify living in acquired properties and confirm the size of the household in older to calculate the amount of cash compensation.

#### For domestic tenant

It is suggested that affected tenants preserve the following documents as the supporting documents:

- 1. Copy of identity card or birth certificate for all living in the affected unit
- 2. Copy of the marriage certificate

(or copy of the certificate of making Decree Nisi Absolute (Divorce) / child custody file) (IF only)

- 3. Income proof ,eg: Bank statement (IF only)
- 4. Student handbook (IF only)
- 5. Copy of documents indicating the amount of Comprehensive Social Security Assistance (IF only)
- 6. Tenancy agreement and Rental receipts
- 7. Residential proof
- 8. Demand for Rates and/or Government Rent, water, electricity and telephone bills (IF only)
- 9. The document from the Housing Anthority with the application number (IF only)
- 10. Copy of pension documents or the proof of rental income (IF only)

#### For non-domestic tenant

- 1. Business declaration: Profit notification and tax return or exemption certificate issued by the Inland Revenue Department
- Limited company: Certificate of Profit and Assets
   (Financial status of not less than 12 months and not more than six months from the date of registration)
- 3. Non-limited company: financial report certified by a certified public accountant (Financial status of not less than 12 months and not more than six months from the date of registration)
- 4. Current Equity Distribution Proof
- 5. A signed copy of the application for business registration
- 6. Business Registration Certificate

## Policy Address(abstract)

## 1. Housing

- The HKHA is planning or undertaking 10 redevelopment projects to provide some 32 800 flats in total.
- HKHA will continue to apply innovative construction technologies, as well as testing and improving the techniques of the MiC approach, to enhance building quality and expedite construction.
- set the minimum standards of living conditions for SDUs in terms of their building safety, fire safety and hygiene requirements, living space, etc.;
- shorten the applicable period of the Special Stamp Duty (SSD) from three years to two years.
- reduce the respective rates of the Buyer's Stamp Duty (BSD) and the New Residential Stamp Duty (NRSD) to 7.5%.

## 2. Create a Childbearing Environment

- provide a one-off cash bonus of \$20,000 for each baby born today or after in Hong Kong to a parent who is a HKPR. This measure will last for three years
- from the year of assessment 2024/25, we will raise the deduction ceiling for home loan interest or domestic rents from the current \$100,000 to \$120,000
- an additional 10% of the total number of flats will be reserved for the purpose of the "Families with Newborns Flat Selection Priority Scheme"
- "Families with Newborns Allocation Priority Scheme", applications of families that have babies born today or after will have their waiting time for PRH flats reduced by one year.
- Starting from the year of assessment 2024/25, the Government will provide a deduction for expenses on assisted reproductive services under salaries tax and personal assessment, subject to a ceiling of \$100,000 a year.
- Starting from next April, the household and child allowances under the Working Family Allowance Scheme will increase by 15%
- Over the next three years starting from 2024, 10 more aided standalone child care centres (CCCs) will be set up in phases, providing about 900 additional places for day child care services.
- Child Care Centre Parent Subsidy, will be increased from a maximum of \$600 to \$1,000 per month.

## Elderly services

- Starting from the second quarter of next year, the coverage of the voucher extend from care-and-attention places to nursing home places, and provide 1 000 more vouchers
- In 2024-25, the Government will inject an additional \$1 billion into the Innovation and Technology Fund for Application in Elderly and Rehabilitation Care
- In 2024-25, the Government will inject an additional \$80 million into the Elder Academy Development Foundation

## 4. Poverty Alleviation

- The second round of the 'Strive and Rise Programme' will begin
- launch a Pilot Programme on 'Community Living Room'

#### 5. Health

- launch the Primary Dental Co-care Pilot Scheme for private dental check-up services for adolescents aged between 13 and 17
- collaborate with NGOs to enhance emergency and special care dental services to the under-privileged, vulnerable groups with special needs, and persons with disabilities
